2- What type of information we have:

We currently collect and process the following information:

- Personal identifiers, contacts and characteristics (for example, name and contact details)

3 - How we get the information and why we have it:

4 - What we do with the information we have

5 - How we store your information

Your information is securely stored. Contractors are only provided with enough information for them to carry out their role. They have been instructed that they should keep the information secure and destroy it after they have completed their assigned task.

We have undertaken an information audit and established a retention policy for Struan Baptie Property Management. At the end of the retention period, we will dispose of your information by secure shredding.

6 - Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your information in certain circumstances.

Your right to object to processing - You have the the right to object to the processing of your personal data in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the information you gave us to another organisation, or to you, in certain circumstances.
